CONSTRUCTION ACTIVITY #1:

Reconstruction of Intersection at SR-953 / LeJeune Road (NW 42nd Avenue) and NW 27th Street:

Commencing Tuesday, November 28, 2006 through Friday, December 8, 2006: As part of the LeJeune Road Reconstruction Project between NW 25th Street and NW 31st Street, the closure of NW 26th Street has been postponed due to unforeseen conditions during pre-trenching operations. Due to those circumstances, the first segment began with the reconstruction of the intersection at NW 27th Street. Therefore, **NW 27th Street will be temporarily closed to thru traffic** during the reconstruction between NW 26th Street and NW 28th Street and will have access to local businesses only through NW 39th Avenue. **BUSINESS ACCESS DETOUR:** Commuters traveling northbound and southbound LeJeune Road wishing to access businesses on NW 27th Street will need to follow the posted detour and turn on NW 25th Street, continue east until NW 39th Avenue, turn left and continue to NW 27th Street and turn left to access businesses. Crews will be installing a new drainage system along the east side of LeJeune Road, new curb and gutter, sidewalks, driveways, lighting, pavement and markings. This work is being done by Kiewit Southern Corp. on behalf of the Florida Department of Transportation.

Reconstrucción de la Intersección de la Carretera Estatal-953/LeJeune Road (Avenida 42 del NW) y la Calle 27 del NW:

Comenzando el martes 28 de noviembre, 2006 hasta el viernes 8 de diciembre, 2006: Como parte de la Segunda Porción del Proyecto de la Reconstrucción de LeJeune Road, entre la Calle 25 del NW y la Calle 31 del NW, ha sido pospuesto el cierre de la Calle 26 del NW debido a circunstancias imprevistas surgidas durante el proceso previo a la excavación. Debido a esas circunstancias, el primer segmento comenzó con la reconstrucción de la Calle 27 del NW. Por consiguiente, **la entrada y salida de la Calle 27 del NW a LeJeune Road quedará temporalmente cerrada al tráfico** durante la reconstrucción entre la Calle 26 del NW y la Calle 28 del NW y acceso a los negocios locales será posible, solamente, a través de la 39 Avenida del NW. **DESVIO PARA ACCESO A LOS NEGOCIOS:** Los viajantes de LeJeune Road rumbo norte y sur que deseen acceso a los negocios de la Calle 27 del NW deberán de seguir las instrucciones de los carteles de desvío y doblar por la Calle 25 del NW, continuar hacia el este hasta la Avenida 39 del NW, doblar a la izquierda hasta la Calle 27 del NW donde doblarán a la izquierda para tener acceso a los negocios. Los equipos de trabajo estarán instalando un sistema nuevo de drenaje a lo largo del lado este de LeJeune Road, construyendo contenes, aceras, entradas, sistema de alumbrado y pavimento con sus marcas. Este trabajo lo esta llevando a cabo Kiewit Southern Corp. para el Departamento de Transporte de la Florida.

Nearby business interests and residents affected by construction of the Miami Intermodal Center and other nearby construction projects will receive periodic Maintenance of Traffic (MOT) bulletins giving road closure information and suggesting alternate routes. This information is being provided by the One Stop Shop Traffic Information Program sponsored by the Florida Department of Transportation and its partnering agencies Miami-Dade County, Miami-Dade Aviation Department, Miami International Airport, Miami-Dade Expressway Authority, Tri-Rail, Miami-Dade Transit, Miami-Dade Office of Public Transportation Management, Cities of Miami, Hialeah, Miami Springs and Virginia Gardens, and local Utilities. Thank you for your patience while we work to improve the roadways in this area.
