CONSTRUCTION ACTIVITY #1:

Full Closure of Westbound Lane on NW 27th Street from NW 39th Avenue to just East of NW 42nd Avenue (LeJeune Road):

Commencing Monday, June 23, 2008 through Friday, November 14, 2008: Crews will begin installing the barrier wall and maintenance of traffic devices in preparation of Phase II construction for the MIC Roadway Improvement Projects on **Monday, June 23, 2008 at 8:00 P.M.** Once the installation of the barrier wall is complete, the westbound lane on NW 27th Street from NW 39th Avenue to just East of LeJeune Road will be completely closed during the period of **June 23, 2008 through November 14, 2008.** **Business Access will be maintained at all times. Commuters should follow the posted detour on the attached Phase II Map to access NW 27th Street Businesses from NW 39th Avenue through NW 26th Street.** This closure is necessary to begin the installation of the new drainage system and roadwork along NW 27th Street. Work will be performed by MCM Engineering and General Contractors on behalf of the Florida Department of Transportation.

Cierre Completo de la Carrilera Rumbo Oeste de la Calle 27 del NW desde la Avenida 39 del NW hasta el Este de la Avenida 42 del NW (LeJeune Road):

Comenzando el lunes 23 de junio del 2008 hasta el viernes 14 de noviembre del 2008: Los equipos de trabajo comenzaran a instalar la muralla divisoria el **Lunes 23 del Junio del 2008 a las 8:00 P.M.** en preparación para la Segunda Fase de construcción del Proyecto de Mejoramientos de Carreteras del Centro Intermodal de Miami. Una vez que la instalación de la muralla divisoria sea completada la carrilera rumbo oeste en la Calle 27 del NW desde la Avenida 39 del NW hasta el Este de LeJeune Road estará completamente cerrada durante el periodo de **Junio 23 del 2008 hasta Noviembre 14 del 2008.** **El acceso a los negocios se mantendrá abierto en todo momento. Los viajantes deberán seguir la ruta de desvío que aparece en el Mapa de la Segunda Fase incluido con este aviso para acceder a los Negocios de la Calle 27 del NW desde la Avenida 39 del NW a través de la Calle 26 del NW.** Este cierre es necesario para comenzar la instalación del nuevo sistema de drenaje y trabajo de carretera a lo largo de la Calle 27 del NW. El trabajo lo llevara a cabo MCM Engineering and General Contractors para el Departamento de Transporte de la Florida.

*Nearby business interests and residents affected by construction of the **Miami Intermodal Center** and other nearby construction projects will receive periodic Maintenance of Traffic (MOT) bulletins giving road closure information and suggesting alternate routes. This information is being provided by the **One Stop Shop Traffic Information Program** sponsored by the **Florida Department of Transportation** and its partnering agencies **Miami-Dade County, Miami-Dade Aviation Department, Miami International Airport, Miami-Dade Expressway Authority, Tri-Rail, Miami-Dade Transit, Miami-Dade Office of Public Transportation Management, Cities of Miami, Hialeah, Miami Springs and Virginia Gardens, and local Utilities.** Thank you for your patience while we work to improve the roadways in this area. 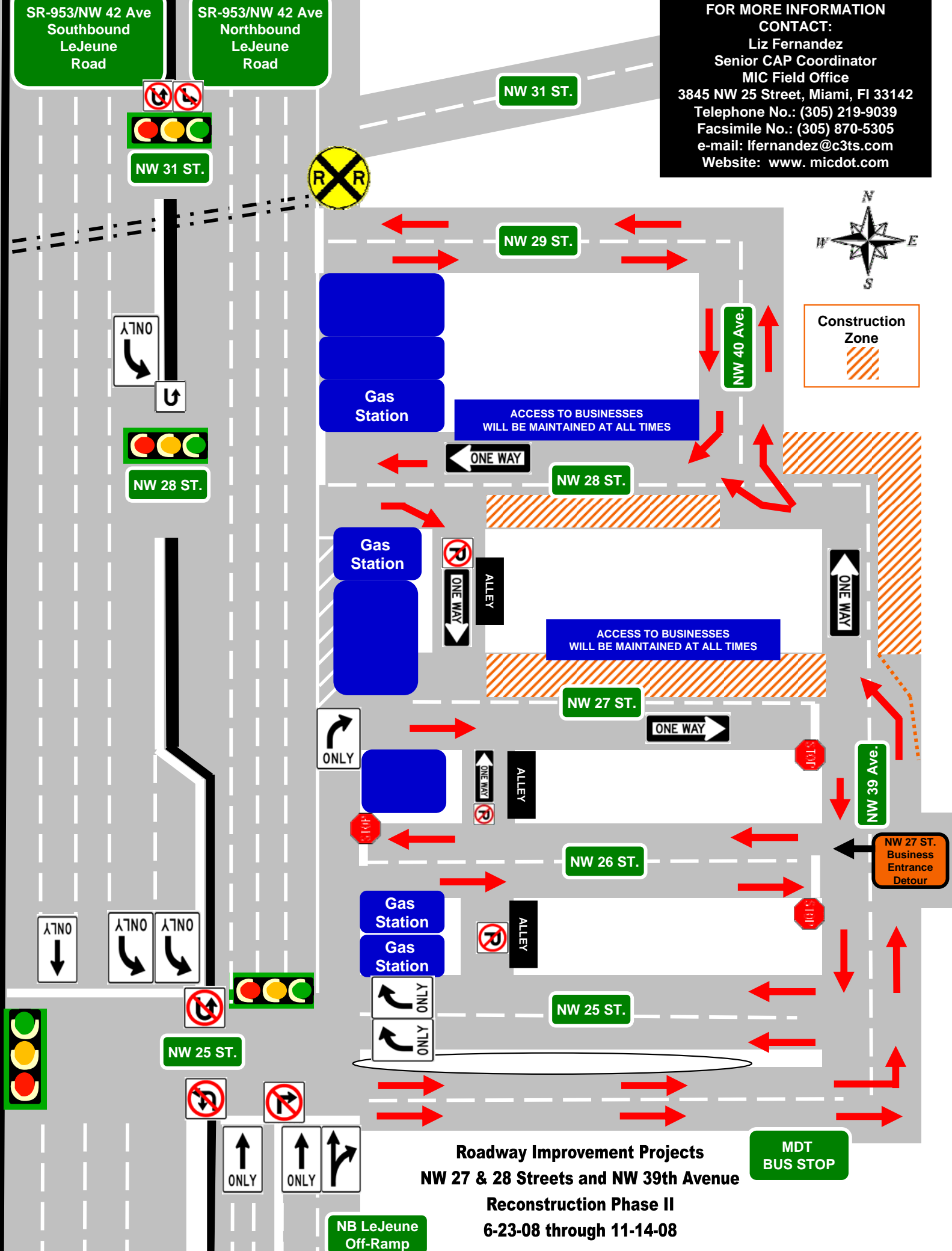
